MIRACLE MILE IMPROVEMENT DISTRICT BOARD OF DIRECTORS NOMINATION FORM

A position on the Board of Directors of the Miracle Mile Improvement District should not be taken lightly. Directors are expected to attend (currently virtual via Zoom) a general board meeting each month (second Tuesday of the month, generally 4:00pm) as well as emergency or special meetings if scheduled by the board president. Failure to attend three meetings may result in removal from the board. Directors are also required to participate in committees and are required to attend/assist with the three signature Miracle Mile events (Miracle Mile En Blanc, Car Show & Concert, Holiday Sip & Shop).

All directors shall be a property owner, business owner, or the authorized representative of a property or business owner within the Miracle Mile Improvement District. Any qualified property owner may nominate a potential board candidate, or self-nominate, for one of the open board seats. The Executive Director will send via US mail a nomination form to each property owner paying the MMID assessment. Once nominations have been received, the Executive Director will review nominees, determine whether they are eligible for the open seats, and deliver a list of eligible candidates to the MMID Board of Directors. Elections will take place at the November MMID General Board Meeting. This year's election cycle includes four (4) property owner board positions and one (1) business owner board positions.
